

# PRIVACY POLICY

## Introduction

At **Dr. D. Y. Patil School of Design** (“We,” “Us” or “Our”), accessible from <https://www.dypatilschoolofdesign.com/> (the “Website”), one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by us and how we use it.

## Information we collect.

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

## Log Files

These are not linked to any personally identifiable information.
